

Personal Data Subject Access Request Form

Volunteers, contractors, competitors aged 16 years or over and parents of competitors under 16 years have a right under current data protection legislation to make a request to their organisation for disclosure of copies of personal data on them which is being processed by the organisation, called a Data Subject Access Request (DSAR). If you wish to make such a request, you should complete this form and return it to Mrs Suzanne Rimini, General Secretary, ISGA.

The right enables you to access data being 'processed' by us, ie collected, recorded, organised, stored, altered, held, consulted or used, which specifically identifies you as the 'data subject'.

When we receive a DSAR, we will seek to provide the data to you as soon as possible, and within one month of the date of receipt. In particularly complex cases, it may be necessary to extend the processing of the request to two months. In some cases the data we hold on you will be exempt from the disclosure requirement and if an exemption applies, we will let you know.

We may contact you to ask for further information so that we can deal with the request. We may also require you to provide evidence of your identity. There will be no fee for this service, unless the request is discovered to be unfounded or excessive.

Please complete this form to the best of your ability to enable a swift and effective response from us.

In supplying data to you, we will comply with our data protection obligations. This may mean redacting any data to avoid disclosing the identity of third parties who have not given their consent to their data being disclosed.

We may provide the data by means of hard copy or email.
